How does it work?

1. Trigger detected



A trigger, such as a loitering person or vehicle, an open gate, or intrusion over a wall is detected by smart technology.

2. Threat evaluation



An experienced CAP controller in CAP's world-class Command Centre evaluates the threat.

3. Mobile notification



The resident or another responsible person is alerted via a mobile messaging platform.

4. Unit is dispatched



A CAP tactical Unit (or one of CAP's partner responder networks) is dispatched to investigate if needed.

5. Feedback is sent



Feedback is provided to the client, along with relevant images.

6. Data is collected



The footage and metadata is stored securely to allow for management, reporting and investigation.



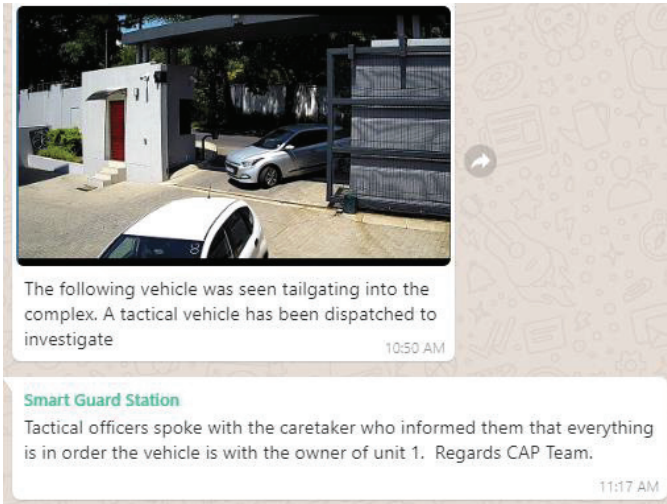
SOLUTION OVERVIEW

1. MONITORING OF THE GATE OPENING FROM THE TIME IT OPENS UNTIL IT CLOSES

Every time the main gate is opened or forced open, a video feed from the camera watching the gate will be viewed immediately in the control room from the time it is opened until the gate closes.

A CAP tactical unit will immediately be dispatched to respond or investigate in the event there is any tailgating of a vehicle by a person or another vehicle.

We will alert you if the gate is left opened and send a tactical vehicle to assist / investigate.



2. ANALYTICS MONITORING TO DETECT ANYONE CLIMBING OVER THE PERIMETER WALL AND ELECTRIC FENCING

When the analytics on a camera is triggered, it will send through a video feed of what triggered the activation through to the offsite monitoring department in the CAP control centre. The footage will immediately be reviewed and assessed. Activations that are clearly not a risk, such as a branch blowing and touching the fence or activating the analytics, then the video feed will be acknowledged and no further action taken. If the video feed shows a person trying to climb the electric fencing, **then CAP tactical resources will be immediately be dispatched to respond.**



3. DETECTION OF SUSPICIOUS/LOITERING PEOPLE & VEHICLES LOITERING IN THE DRIVEWAY

Any people or vehicles that are loitering in the view of the camera for a predetermined time by Cap will trigger an event to the offsite camera monitoring desk in the CAP control room. The event will be viewed by the controller. If deemed potentially suspicious, the CAP controller will immediately dispatch a CAP tactical unit to respond or investigate.
